

# DOCUMENT CHECKLIST Subsequent temporary public policy to continue to facilitate access to permanent resident status for out-of-status construction workers in the Greater Toronto Area (GTA).

You must print this document, complete it and include it in your application as the cover page.

Gather your documents **in the order of the checklist** and check  $\square$  each item. Attach small items such as photos with a paper clip, otherwise leave documents unbound. Place all documents in a sealed envelope and follow the steps in the <u>instruction guide IMM 0124</u>. If your documents are not in English or French, you must include the English or French translation, with a certified copy of the original documents and an affidavit from the person who completed the translation (if the translation is not provided by a member in good standing of a provincial or territorial organization of translators and interpreters in Canada).



Note: If your application lacks any of the documents listed in this checklist, it will be returned to you. If you are unable to provide any of the requested documentation, please include with your application, a written explanation with full details as to why that documentation is unavailable and any documentation that would support your claim. Failure to provide supporting documents in certain circumstances may result in the refusal of your application.



COMMON REASONS FOR THE RETURN OF THE APPLICATION PACKAGE

- Required forms were not signed and dated.
- The information on the documents submitted for the principal applicant and their family members, such as on their passport or birth certificates, does not match the Generic Application Form (IMM 0008).
- An invalid version of a form was submitted with the application package.

Individuals who have made a refugee claim in Canada and failed refugee claimants are not eligible under this public policy.

Family members of the principal applicant eligible for immigration to Canada under this public policy will be granted the same admissibility exemptions.

	You must provide proof that you have continuously resided in Canada for at least 5 years on the date of your application.

5	You must be able to provide proof that you are working without authorization in the construction industry in the Greater Toronto Area (GTA) in one or more of the occupations referenced under the section <u>"Who can apply"</u> .	Copies	
	Proof of employment may include copies of a work contract, an attestation letter from your employer, or proof of membership in a local union within the GTA, payment of union dues.

	<ul> <li>Provide evidence of, 3 years full-time cumulative work experience within the past 5 years in construction in the GTA in one or more of the occupations referenced under the section <u>"Who can apply"</u>.</li> </ul>

8	<ul> <li>Family/relatives in Canada</li> <li>Provide proof of having a relative: (mother, father, brother, sister, grandmother, grandfather, grandchild, aunt, uncle, niece, nephew or cousin) living in Canada who is a Canadian citizen or permanent resident.</li> <li>To prove that you have a relative in Canada you must demonstrate your family ties. You can submit copies of a birth certificate or family booklet.</li> <li>You will need to include a copy of their valid permanent resident card, citizenship certificate, or a copy of the first page of their Canadian passport.</li> </ul>	Copies	
9	<ul> <li>Children's Information, if applicable <ul> <li>Children's birth certificates (which name their parents)</li> <li>School records</li> </ul> </li> <li>If you have adopted dependent children: <ul> <li>adoption papers issued by recognized national authorities showing the legally approved adoption</li> </ul> </li> <li>If the other parent is not accompanying you to Canada: <ul> <li>custody papers for children under the age of 18 from a previous marriage or relationship</li> <li>a signed Statutory declaration from a non-accompanying parent/guardian for minors immigrating to Canada (IMM 5604)</li> </ul> </li> <li>NOTE: You must submit one form for each child and a copy of the non-accompanying parent's photo ID showing their signature</li> </ul>	Copies	
10	Police Certificates and Clearances You, and your family members 18 years of age or older, that aren't Canadian citizens or permanent residents, must get a police certificate from each country or territory where you have lived for six or more consecutive months in a row since the age of 18. You are strongly encouraged to submit them with your application to the Canadian Labour Congress. If you are unable to obtain all the necessary police certificates, you may still send your application without them. However, we strongly recommend that you take steps to obtain your police certificates <b>now</b> to avoid future delays. You must be ready to submit them when requested by an officer. Find specific and up to date information on how to obtain police certificates from any country or territory.	Original	
11	Photo Requirements Include two (2) passport-size photos for you and each member of your family, whether accompanying or not. On the back of one (1) of the photographs, the photography studio must have indicated its name and complete address, the name and date of birth of the person who appears in the photo, as well as the date the photo was taken. Leave the other photograph blank. Include two (2) additional photos in order to process the Temporary Resident Permit. Photos must have been taken by a commercial photographer within 6 months before application submission and not have been altered. Follow the instructions provided in the instruction guide in <u>Appendix A: Photo Specifications</u> .	Original
